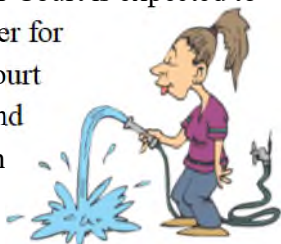


## Water Sales Update

The developers and the HOA have now jointly submitted the application to the Colorado Water Court to enable sale of additional water to Kings Deer Owners. The legal process allows two months for comments from possible impacted water users, then a period of time will be required to address and resolve any concerns that arise. Once issues are resolved, the Water Court is expected to approve the sales of additional water for lots. The needed duration for the court process is unsure, and the details and conditions of any sale are uncertain until the final court decree is issued. However, we hope that sometime late in 2019 details will be available and sale of water to interested homeowners may begin.



## Vehicle Parking

Paragraph 23 in our community covenants address vehicle parking requirements within King's Deer. The current language in both covenants is rather restrictive, requiring residents to store or park their vehicles in a closed garage or "other structures". The original authors of our covenants believed that driveway's clear of vehicles improve the overall appearance of the community. Over the years, HOA Boards have found that enforcement of parking covenants is one of the more difficult issues for the HOA to address. Additionally, many (possibly most) residents of King's Deer would prefer that the community change these covenants to allow more flexibility.

The Board recognizes there is interest within the community to make changes to our existing parking requirements. The changes being considered (e.g., allowing up to two cars to be

## Architectural Control Committee

The ACC meets twice per month on the second and fourth Thursdays except in November and December when it meets only on the second Thursday. Meetings are held at 5PM in the Golf Club House. All projects must be submitted no later than Wednesday before the meeting. It is suggested that if you have a proposed project you attend the meeting in the event there are questions or problems with the submittal. Also, there are conditions when the office is closed, or insufficient members are available so that a meeting must be cancelled. We will post that as far in advance as possible on the HOA Facebook page and on Next Door. We recommend you use those pages for information.

Additionally, the ACC will attempt to resolve all project requests on first submission or within 30 days, but weather or project problems may

extend the time required to complete evaluation up to 60 days. Thus, projects should be submitted early enough to allow for additional time for problem resolution in the approval process.

Approved projects are to start within 60 days of approval by the ACC. If additional time is required, the owner must request that extension from the ACC. Projects must be completed, including new homes, within 9 months after the start of the project. This is to avoid neighbors having to deal with construction traffic, noise, and other factors for extended periods. Our goal is to approve projects as quickly as possible. By attending the ACC meeting at which your application is reviewed you provide immediate responses to questions from the committee and therefore greatly improve your chances of obtaining a fast approval for your project. 🐾

a contact phone number in case we need clarification on something. Names and phone numbers will not be included in the map. If you plan to only participate in one or two of the three days, it is helpful to let shoppers know by including a statement indicating the days or times you will be participating. The HOA does not set any specific time to start or end each day, but experience has shown that Friday and Saturday are the most popular shopping days, and an 8 AM start is most common, with most shopping activity finished by 1 PM. parked outside), would require an amendment to both the Classic and Highlands covenants. The board unanimously agreed to enable King's Deer residents to decide this matter through a vote. Thus, we will insert a covenant change ballot measure in the same mailing with the Board election ballot this fall. To amend covenants will require a significant increase in resident participation in the next election. Requirements for amending the covenants are outlined in paragraph 27 of Classic and Highland's covenants. 🐾

*There are a lot of significant outdoor events King's Deer residents can take advantage of over the next few months. Several of the larger activities are as follows:*

### Tri-Lakes Kids Fishing Derby

Saturday, 1 June 2019, 8 – 11:30 am, Palmer Lake

Tri-Lakes Lions Club is hosting the annual Tri-Lakes Kids Fishing Derby on 1 June (Saturday) at Palmer Lake in Northern El Paso County. The tournament will begin at 8 am and conclude with presentation of awards at 11:30 am. The fishing tournament is targeted for kids 4 through 14. The event is FREE, although kids are asked to bring a non-perishable food item for donation to Tri-Lakes Cares at registration. Colorado anglers of all ages can fish without a license on 1 June, so parents and other chaperons are encouraged to bring their fishing gear and join in the fun. The Colorado Parks and Wildlife is stocking the lake with trout for the tournament. Participants will need to bring their own fishing equipment and bait. For those who do not have fishing gear, there will be a limited number of rods, reels, and bait, that can be used on a “loaner basis” for kids participating in the Derby. Tournament registration opens at 7:30 am on the East side of the lake next to bathrooms and park pavilion.
