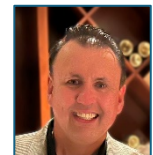
Mike Sauer – President & Common Area Maintenance (term expires Nov 2026)

Tim Beichley – Director (term expires Nov 2027)

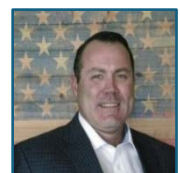
